



Memorandum of Understanding

between

THE UNIVERSITY OF JORDAN

in AMMAN

AND

THE NATIONAL DEFENCE UNIVERSITY

in WARSAW

concerning bilateral academic cooperation

The University of Jordan (with its location in Amman) and the National Defence University (with its location in Warsaw) hereafter referred to as the "Participants",

Wishing to develop bilateral academic cooperation within the competence of the Participants,

Conclude this Memorandum of Understanding (hereafter referred to as the "MoU") and agree to the following:

Section 1

The Participants shall develop the following collaborative activities in academic areas of mutual interest:

- 1) exchange of faculty members and researchers for purposes of teaching and conducting research;
- 2) exchange of students subject to terms to be outlined in a separate Student Exchange Agreement;
- 3) conducting collaborative research projects;
- 4) commonly organizing of symposia, seminars, and conferences;
- 5) exchange of academic information and materials.

Section 2

The development and implementation of specific activities based on this MoU will be agreed between the faculties or institutes, which will carry out the specific projects. The Participants agree to carry out these activities in accordance with the laws and regulations of their countries.

Section 3

It is understood that the implementation of any of the types of cooperation stated in Section 1 shall depend upon the availability of resources of both Participants.

Section 4

Should any collaborative research activities under this MoU result in any potential for intellectual property, both Participants shall seek a fair understanding as to ownership and other property interests that may arise.

Section 5

Within the cooperation under this MoU no classified information shall be exchanged by the Participants.

Section 6

- 1. This MoU is done in duplicate in English language. In case of a different interpretation the Participants shall enter into consultations.
- 2. This MoU is valid for an unlimited period until it is terminated according to par. 3 of this Section.

- 3. This MoU may, at any time during its period of validity, be terminated by either Participant upon written notice delivered to the other Participant not later than six months prior to the intended termination date. The termination will not affect ongoing activities.
- 4. This MoU may be amended or modified by written consent by the Participants. In such a case amendments and/or modifications shall become integral part of this MoU.

Memorandum of Understanding on Academic Cooperation between the University of Jordan and the University of Warsaw



First Party: The University of Jordan, Amman, 11942 Jordan, represented by its President or designated officer.

Second Party: The University of Warsaw, 00-927 Warsaw, Krakowskie Przedmieście 26/28, Poland, represented by its Vice-Rector for Research and Liaison.

Whereas the two Parties desire to develop academic cooperation in various fields, the two Parties conclude this Memorandum of Understanding (MoU) and agree to the following terms:

Article 1 – To develop the following collaborative activities in academic areas of mutual interest:

- 1. Exchange of faculty and researchers for purposes of teaching, delivering lectures, conducting research, and exchange of expertise;
- 2. Exchange of students subject to terms to be outlined in a separate Student Exchange Agreement;
- 3. Conducting collaborative research projects;
- 4. Jointly organize symposia, seminars, and conferences;
- 5. Exchange of academic information and materials.

Article 2 – The development and implementation of specific activities based on this MoU will be separately negotiated and agreed between the faculties or institutes, which carry out the specific projects. Both Parties agree to carry out these activities in accordance with the laws and regulations of both countries.

Article 3 – It is understood that the implementation of any of the types of cooperation stated in the Article 1 shall depend upon the availability of resources and financial support of both parties.

Article 4 – Should any collaborative research activities under this MoU result in any potential for intellectual property, both Parties shall seek a fair understanding as to ownership and other property interests that may arise.

Article 5 – This MoU may be amended or modified by written agreements signed by the representatives of both Parties, and will become part of this MoU.

Article 6 – This MoU is valid for a period of four years commencing on the date of the last signature, and may be renewed after being reviewed and renegotiated by both Parties.

Article 7 – This MoU may, at any time during its period of validity, be terminated by one of the Parties upon written notice to the other Party not later than six months before the termination date. The termination will not affect ongoing activities.
