MEMORANDUM OF UNDERSTANDING

Jordanian American Physicians Association, hereinafter referred to as "JAPA", and the University of Jordan. enter into the following terms of this Memorandum of Understanding (MoU) with respect to furthering international cooperation in medical research and education.

ARTICLE 1: PURPOSE

The parties pledge themselves to cooperate in a spirit of greater understanding, to deepen friendly relationships and ties of mutual benefit, and to foster collaboration. The parties will undertake to initiate joint activities, including, but not limited to:

- Organizing and performing joint research projects, academic seminars, and faculty guest lectures by JAPA members.
- b. Creation of co-branded teaching materials and lectures by JAPA and the University of Jordan physicians for placement on JAPA academy website which has been accredited by the Jordanian High Medical Council as a continuous professional development education platform.
- c. Arranging elective and observership opportunities for University of Jordan medical school students.
- d. Submission of scholarly materials, research reports, publications, and other relevant activities by University of Jordan faculty to JAPA Academy Journal.
- e. The University of Jordan will consider JAPA members participating in these activities for Adjunct Professor titles, in accordance with its valid regulations and bylaws.

ARTICLE 2: SPECIFIC AGREEMENTS

To implement the above activities, the parties must outline the detailed content in separate agreements.

ARTICLE 3: FINANCIAL

This MoU does not create a financial obligation between the parties; therefore, no money shall be exchanged between the parties. To finance specific activities, the parties may obtain necessary financial assistance from individuals, or institutions, both private and public, in addition, JAPA will provide help and assistance in fundraising drives for the University of Jordan initiatives.

ARTICLE 4: OTHER PROVISIONS

This MoU constitutes the entire agreement between the parties. There are no understandings or representations, oral or written, not specified in this MoU. No amendment, consent, or waiver of the terms of this MoU shall bind the parties unless it is in writing and signed by all parties.

ARTICLE 5: EFFECTIVE DATES AND DURATION

This MoU is valid for five (5) years from the date of signing. It may be extended by mutual consent upon a request for renewal along with a report of the activities pursued under the auspices of this MoU, submitted prior to its date of expiration.

ARTICLE 6: TERMINATION

This MoU may, at any time of its period of validity, be terminated by one of the parties upon written notice to the other party not later than six months before the termination date. The termination will not affect ongoing activities.

ARTICLE 7: REPRESENTATIONS AND WARRANTIES

The signatories of the MoU agree and affirm that they have the authority to bind their institutions. This MoU is not legally binding under national or international law. Its sole purpose is to promote collaboration.
