



Memorandum of Understanding

on Academic Cooperation

between

The University of Jordan

and

Universidad Anáhuac México

First party: The University of Jordan, Amman, 11942, Jordan, represented by its President or designated officer.

Second party: Universidad Anáhuac México, north campus Investigaciones y Estudios Superiores, S.C. and south campus, Universidad Anáhuac del Sur, S.C., represented by its President and its Legal Representative.

Whereas the two parties desire to develop academic cooperation in various fields, the two parties conclude this Memorandum of Understanding (MoU) and agree to the following:

Article 1- To develop the following collaborative activities in academic areas of mutual interest:

- 1. Exchange of faculty and researchers for purposes of teaching, conducting lectures, conducting research, and exchange of expertise.
- 2. Exchange of students subject to terms to be outlined in a separate Student Exchange Agreement.
- 3. Conducting collaborative research projects.
- 4. Jointly organize symposia, seminars, and conferences.
- 5. Exchange of academic information and materials.

Article 2- The development and implementation of specific activities based on this MoU will be separately negotiated and agreed between the faculties, or institutes, which carry out the specific projects. Both parties agree to carry out these activities in accordance with the laws and regulations of both countries.

Article 3- It is understood that the implementation of any of the types of cooperation stated in Article 1 shall depend upon the availability of resources and financial support at both parties.

Article 4- The two parties will agree to the division of ownership and returns of intellectual property prior to commencing any collaborative research activities, under this MoU, that may result in intellectual property.







Article 5- This MoU may be amended or modified by written agreements signed by the representatives of both parties, and will become part of this MoU.

Article 6- This MoU is valid for a period of four years commencing on the date signed by the last party, and may be renewed after being reviewed and renegotiated by both parties.

Article 7- This MoU may, at any time during its period of validity, be terminated by one of the parties upon written notice to the other party not later than six months before the termination date. The termination will not affect ongoing activities.

Article 8- The parties will comply with all applicable laws or regulations related to the acceptance, transmission and / or storage of personal data, including, but not limited to, the notification, consent, security and record retention provisions, , so they must:

- 1. Keep absolute confidentiality regarding personal data that they know as a result of the present agreement;
- 2. Implement the administrative, physical and technical safety measures established in the applicable regulations;
- 3. Treat personal data only for the purposes provided in this instrument and refrain from using them for different purposes;
- 4. Refrain from transferring personal data without the consent of the owner, unless one of the exceptions provided for in the corresponding legislation is updated;
- 5. Ensure that the personnel who know the personal data is the one that is strictly necessary for the proper fulfillment of the obligations generated as a result of this agreement and to instruct them on the confidentiality terms for the same.
- 6. Inform when a violation of personal data occurs, and
- 7. Delete personal data subject to processing once the legal relationship is fulfilled.

The PARTIES undertake to be responsible for the damages that are caused or could be generated by the disclosure, inappropriate or unauthorized use that is given to the confidential information or personal data, through their personnel or any third party acting on their behalf, so they agree to hold harmless the other party against any claim that was required judicially or extrajudicially by third parties.







The foregoing, without prejudice to the actions that could be taken before the competent authority to report the alleged commission of administrative violations or criminal acts.
