



Memorandum of Understanding

First party: The University of Jordan, Amman, 11942, Jordan, represented by its President or designated officer.

Second Party: The Board of Regents of the University of Nebraska, a public body corporate, for the University of Nebraska Medical Center, 987810 Nebraska Medical Center, Omaha NE 69198, United States of America

hereinafter referred to as the parties

This document serves as a Memorandum of Understanding (MOU) between the Board of Regents of the University of Nebraska a corporate public body, for and on behalf of the University of Nebraska Medical Center (hereinafter called "UNMC"), 987810 Nebraska Medical Center, Omaha NE 69198, United States of America and The University of Jordan (hereinafter called "UJ"), Amman, 11942, Jordan, an institution of higher education located in Amman, Jordan.

Article (1)

Purpose

UNMC and UJ enter into this Memorandum of Understanding to establish cooperation between faculty members to **explore potential collaborative projects in education, research and clinical health care.**

The introduction to this memorandum and its appendices, if any, are considered an integral part of it and should be read with it as one unit for all purposes and objectives.

Article (2)

Discussion and Development of Possible Collaboration between parties

In accordance with the laws and regulations in force at both Parties and Within the fields of education, research and clinical health care, to be mutually designated, both parties agree to



discuss and explore the development of any one or more of the following general forms of cooperation :

1. To exchange information about medical and public health best practices in order to improve adult and child health in both countries.
2. To collaborate on medical, education, and research initiatives of mutual interest in both countries
3. Foster collaborative, respectful relationships and open communication across cultural and geographic boundaries, in both healthcare and public health settings, in order to achieve the above-mentioned educational and research initiatives.
4. Exchange of research materials, publications and information.
5. Development and operation of joint academic programs.
6. Support for distance learning courses.
7. Organization of joint research programmes.
8. Exchange of students, residents, fellows, academic, and administrative staff & other non-academic staff for purposes of education, training and research.
9. The development of common curricula in areas of mutual interest.
10. Organization of joint conferences or workshops in (research) areas of mutual interest.

Article (3)

Term of the MOU

1. This MOU takes effect on the date it is signed by authorized representatives from participating institutions and will continue in effect for 3 years. The term of this MOU may be modified at any time by mutual consent and either party may cancel the MOU at any time, with or without cause, and without any obligation beyond those which may be established by subsequent additional written agreement between the parties. Further, this



MOU shall not be construed as exclusive such that either or both organization may enter into similar arrangements with other parties as they solely may deem appropriate.

2. As specific projects in education, training, or research are identified and mutually agreed upon, each will require a separate written agreement which will set forth the terms and conditions of the project(s). These separate agreements will not be valid unless and until approved and signed by appropriate administrators at each institution.

Article (4)

Use of Names

All parties agree that they will not use the name, logo, registered trademarks or other symbols of the other party in signatures, headings, letterhead, brochures, announcements or any other way without the prior written consent from such party, which consent may be withheld or conditioned in that party's sole and absolute discretion.

Article (5)

Miscellaneous

-Nothing in this MOU obligates either party to an expenditure of funds with respect to any proposed collaboration where neither UJ nor UNMC will bear any financial costs or liability of any kind or cause.



-Any doubts, ambiguities or disputes, if any, regarding the interpretation of the provisions of this Memorandum of Understanding or any of its appendices shall be resolved through mutual consultations between the two parties and in amicable ways as possible.

-This MOU shall be governed by the laws of the State of Nebraska, along with its applicable federal laws. All legal actions shall take place in the jurisdiction of Lancaster County, State of Nebraska, U.S.A.

-UJ represents and warrants it, nor any, employee, agent, or representative participating under the terms of this Agreement are (i) currently excluded, debarred, or otherwise ineligible to participate in the Federal health care programs as defined in 42 USC § 1320a-7b(f) (the "Federal healthcare programs"); (ii) convicted of a criminal offense related to the provision of healthcare items or services, but have not yet been excluded, debarred, or otherwise declared ineligible to participate in the Federal healthcare programs, and (iii) under investigation or otherwise aware of any circumstances which may result in being excluded from participation in the Federal healthcare programs. UJ agrees to comply will all applicable U.S. laws and regulations controlling the export of technical data, computer software, laboratory prototypes, and other commodities that may require a license from the applicable agency of the U.S. government. UJ agrees to comply with export control laws, including the International Traffic in Arms Regulations (ITAR), 22 CFR 120-130, the Export Administration Regulations (EAR) 15 CFR 730-774, and the Foreign Assets Control Regulations 31 CFR 501-598.

Article (6)

This MOU, effective on signature date is entered into by and between the University of Nebraska Medical Center, with its principle place of business at 987810 Nebraska Medical Center, Omaha, NE, United States of America and the University of Jordan with its principle place of business at Amman, Jordan.
